## **NOTIFICATION**

No. HE-UE-POLICY-0019-2023- <u>52566</u> /HE., In exercise of the powers conferred under Section-32 of the Odisha Universities Act 1989, Government have been pleased to merge 2nd campus of Maharaja Sriram Chandra Bhanja Deo University with Dharanidhar University, Keonjhar with all movable and immovable assets under following terms and conditions.

- 1. All the sanctioned posts of 2nd campus of Maharaja Sriram Chandra Bhanja Deo University shall be transferred to Dharanidhar University, Keonjhar and deemed to be created in Dharanidhar University, Keonjhar w.e.f. from the date of this Notification.
- 2. All the students enrolled at 2nd campus of Maharaja Sriram Chandra Bhanja Deo University will continue to be under jurisdiction of Maharaja Sriram Chandra Bhanja Deo University till completion of their course.
- 3. The teaching faculties of 2nd campus of MSCB University who opted for Dharanidhar University shall be absorbed against the vacancy in the Dharanidhar University as the posts of 2nd campus is also absorbed in the Dharanidhar University.
- 4. Faculty of Sanskrit, who chose to continue with Maharaja Sriram Chandra Bhanja Deo University is allowed to be transferred to Maharaja Sriram Chandra Bhanja Deo University against their existing vacancy.
- 5. One faculty of Odia who desires to go to Maharaja Sriram Chandra Bhanja Deo University, but as there is no post of Odia in Maharaja Sriram Chandra Bhanja Deo University, he may be absorbed in Dharanidhar University and deployed to Maharaja Sriram Chandra Bhanja Deo University, if he desires after seeking option from him.
- 6. New admissions will be under Dharanidhar University, Keonjhar from the date of incorporation of Dharanidhar University or any other date as decided by Dharanidhar University.
- 7. The Government land allotted in favour of Maharaja Sriram Chandra Bhanja Deo University (2nd campus) shall be alienated in favour of Dharanidhar University, Keonjhar, as its ownership is vested with DD University.
- 8. No fresh admission of students shall be made in the 2nd campus of Maharaja Sriram Chandra Bhanja Deo University with effect from 2023-24. Fresh admission in this premise will be done under DD University only.
- 9. The Registrar of Maharaja Sriram Chandra Bhanja Deo University shall hand over all official files/records/documents of 2nd campus to the Registrar of Dharanidhar University who shall keep them under safe custody of Dharanidhar University for future reference.

10. All liabilities and litigations relating to 2nd campus of Maharaja Sriram Chandra Bhanja Deo University shall also be looked after by Dharanidhar University from the date of the notification.
