
CORRIGENDUM

Sub: Implementation of provisions for the disabled students Madam / Sir,

In pursuance to this Department Order No.34010 dated 13.12.2017, on the subject cited above, I am directed to intimate you that all academic fees except mess charges have been waived in respect of students with disabilities of 40% or more and the expenditure in this regard was to be met by the Aided Colleges from their own internal resources. Now, it has come to the notice of Government for some ambiguities with regard to Academic Fees.

After careful consideration, it has been decided to include the following fees under "Academic Fees" which shall be waived in respect of students with disabilities of 40% or more admitted in State Public Universities/ Government & Aided Colleges coming under this Department.

- 1. Admission fees and re-admission fees
- 2. Tuition Fees
- 3. Magazine Fees
- 4. Calendar Fees
- 5. Library Fees
- 6. Reading and Common Room Fees
- 7. Time Table Fees 💅
- 8. Proctor and Work Experience Fees
- 9. Abstract of Attendance Fees /
- 10. All semester examination fees 🗸

However, it is important to clarify that for the students admitted in selffinancing Courses, where all the expenditures are met from the funds received from students (e.g. remuneration to teaching and non-teaching staff, guest faculties, lab maintenance & other logistics support etc.), the waiver of aforementioned academic fees as well as the hostel fees shall not be applicable.

This shall come into force with immediate effect.
